RESERVED STARTING TIME AGREEMENT

1. Reserved starting times are for Saturday or Sunday from 6:00AM – 10:00AM, starting the first weekend in April through the last full weekend in October 2016 (30 weeks total)
2. Membership Includes (applies to all 4 players):
 - a. Range Pass (Unlimited Practice Balls)
 - b. USGA Computerized Handicap Membership (\$32 per person value)
 - c. Guaranteed Starting Time every week
 - d. Discounted Green Fees (\$10 off Regular Weekend Rates)
 - e. 20% Off All Golf Shop Merchandise (only on non-sale items)
 - f. Discounted Club Storage, Limited to the first 20 members
 - g. Discounted Locker Fees
 - h. Unsurpassed Service!
3. Foursomes must report to the Golf Shop 30 minutes prior to Reserved Starting Time (RST), or their starting time will be forfeited. Foursomes must be on the tee box ten minutes before the RST.
4. If a foursome would like to cancel or adjust their RST, they must call the Golf Shop no later than 6PM the night before the RST. Failure to change or cancel by the allotted time will result in a \$25.00 charge per NO SHOW to Applicant #1's Credit Card (see below). Golfing privileges will be suspended until the fee is paid. This will be strictly enforced for the 2016 season.
5. RST Pricing and Purchase under the following conditions:
 - a. ~~\$2800~~ \$2,000 for 30- weeks April 2nd & April 3rd through October 29th & 30th , 2016.
 - b. A non-refundable deposit of \$600 is required by Dec.31st, 2015 to hold the Reserved Tee Time.
 - c. RST shall be paid in full on or before March 15, 2016

Failure to pay remaining balance of RST by above date will result in the forfeit of RST along with the full amount of deposit.

6. Golf Cart use is mandatory for all RST. By signing this contract you agree to abide by Middle Island Country Club standards of golf cart usage, as follows:
 - a. Carts are to be kept 30 feet away from greens and tee boxes, unless cart path is provided.
 - b. Keep feet inside golf cart at all times.
 - c. Only two people per cart.
 - d. Golf Carts are to remain on Middle Island Country Club property at all times.
 - e. MUST HAVE A VALID DRIVER'S LICENSE TO OPERATE/RENT GOLF CART.
 - f. We reserve the right to refuse the use of a golf cart to anyone.
