TERMS OF MEMBERSHIP

- In order to activate a house account and receive charging privileges, I agree to provide the Club with a valid credit card number as requested. I understand that the balance of my house charge account will be billed to my credit card for all charges unpaid for 60 (sixty) days or more. If I choose not to activate a house account, I understand I may elect to have any and all charges that are due at the first of each month automatically deducted from a designated bank account. In order to have my bank account automatically deducted, I agree to provide the Club with the name, address and phone number of the banking institution, along with a voided check or voided deposit slip.

- Each month, the Club will mail my statements showing any charges due to the Club indicated on the reverse side. Dues are billed on the first day of each month. Charges are due upon receipt of my statement and are considered delinquent if not paid by the end of statement month. A late fee and finance charges will be assessed to any and all accounts over 30 (thirty) days late. Members whose charges remain delinquent for 60 (sixty) days or more will have their membership privileges suspended until the account is paid in full. If the account is paid in full within 30 (thirty) days of suspension, there is a \$50 reinstatement fee to reactivate the membership. If the account remains unpaid beyond 90 (ninety) days, the membership will be revoked with no eligibility to transfer the membership. If my membership is terminated for delinquency, and if collection of my account requires the assistance of attorneys or a collection agency, I (we) agree to pay the additional amount due on the account, reasonable attorney and court costs, as well as any initiation fees or dues owed.
- I further understand that I may resign from the Club following my first 12 (twelve) month commitment by giving 30 (thirty) days advanced written notice to the Club. Should I choose to resign prior to my first anniversary date, I agree to pay the remaining dues for the 12 (twelve) month period up to my first anniversary date, and all other charges for which I may be liable, and I shall not thereafter be subject to any further dues or charges.
- I hereby acknowledge that the use of the Club facilities and any privileges or service incident to Membership is undertaken with knowledge of risk of possible injury. I hereby accept any and all risk of injury to myself, my guests, and family sustained while using the Club facilities or involved in any event or activity incident to Membership at the property. By accepting risk of injury, I understand that I am relieving the Club, their successors and assigns, their respective directors, officers, partners, shareholders, employees, agents and affiliates from any and all loss, claims, injury, damages or liability sustained or incurred by me, my guests and my family resulting from or arising out of any conduct or event connected with Membership in the Club and use of the Club facilities.
