

Membership Status

Membership in the Country Club shall be open to persons of good, moral character who are interested in golf, swimming, tennis and social activities for the benefit of the members and the community.

Membership is available without regard to race, color, sex or national origin.

FAMILY

Golf — Full club privileges for the married member, spouse and children under the age of 21.

Associate Golf — Full *Family* club privileges for members ages 21—49.

Social — Club privileges include use of the clubhouse, tennis courts and swimming pool for a member, spouse and children under 21. For an additional cost, you may play golf a maximum of four (4) times a month.

SINGLE

Golf — Full club privileges for an individual.

Social — Club privileges include use of the clubhouse, tennis courts and swimming pool for an individual. For an additional cost, you may play golf a maximum of four (4) times a month.

NON-RESIDENT

Family — Available to person (s) whose primary resident is outside of Citrus County. A minimum commitment of one (1) month up to a maximum of five (5) months during a calendar year is required. Golf rental is mandatory.

Single — Club privileges include use of the clubhouse, tennis courts and swimming pool for an individual.

CORPORATE

Golf — Full club privileges for four (4) members and spouses who are full-time officers and/or senior management.

Social — Club privileges include use of the clubhouse, tennis courts and swimming pool for four (4) members and spouses who are full-time officers and/or senior management.

JUNIOR

Golf — Full club privileges to a person up to age 21 if family is not a member of IGCC.

About Us

INVERNESS, FLORIDA is home to one of the best kept golf secrets. Inverness Golf & Country Club (IGCC) is a privately owned club, located south of Inverness off U.S. Highway 41 in Citrus County.

Established in 1960, Inverness Golf & Country Club maintains a roster of approximately 250 members who enjoy teeing it up most any-time they desire, organized play groups, fine dining, lounging by the pool or a friendly game of shuffleboard or tennis.

IGCC's membership currently is composed of junior through senior golfers. The membership consists mostly of retired golfers and members who are active in area businesses and the professional community.

Our 18-hole course is nestled in a setting of large oak trees, pines, palms and a few cedars that can get hookers and slicers into trouble. It is a fairly level layout that is rated 69.4 from the white tees and 71.3 from the red. Water hazards come into play only on two holes on the front side, eight and nine, and two holes on the back, fourteen and fifteen. Although, errant shots can find lateral hazards on several other holes. All greens were replaced in the Summer of 2006.

In addition to the 18 hole golf course, the club offers a club house with restaurant, dining room and lounge; pro shop; swimming pool; lighted tennis courts; driving range and practice putting green.
