POLICIES: Additional \$200 deposit required for shotgun tournaments.

Receipt of contract with credit card number/deposit will reserve tournament date and time. All green fees and meals must be paid in one lump sum 7 days in advance.

Cancellation Policy: Shotgun Tournament – Full refund 14 days prior to event.

Tee times: Number of players to be confirmed 7 days prior with payment.

Pace of play for tee time tournaments: Groups need to maintain a pace of 2 hours, 15 min per nine holes as we will have other golfers before/after your tournament. If you feel your group cannot maintain this [pace please ask about other options.](#)

All Alcoholic Beverages must be purchased from Eagle Creek Golf Course

Players are expected to practice basic golf etiquette. Organization/tournament coordinator will be held liable for any damage to golf course property.

1. A \$200.00 deposit is required to hold a date for any event. This deposit will be deducted from the total invoice at the conclusion of the event.
2. You must submit a player list at least 30minutes prior to your event.
3. Unless the golf course is closed due to severe weather, the tournament/outing must play and/or continue play no matter what the conditions are. Eagle Creek Golf Course professional staff will decide the severity of any current/approaching weather conditions.
4. All players must be instructed to check in at the respected registration table a minimum of 30 minutes in advance of the start of the event.
5. All shotgun start Tournament/Outings must finish within 5 hours of the official start time!
6. Persons who are visibly intoxicated and/or minors will not be served alcoholic beverages.
7. Any person disrespecting property and/or doing damage to the course or clubhouse will be removed from the premises immediately with no refund available.

8. Any/all damages done by a tournament/event participant, volunteer, committee member will be the responsibility of the tournament/event and such costs will be added to the final invoice. Eagle Creek Golf Course is not responsible for any lost or stolen items.

9. A final count of players and meals is required 5 days prior to the start of the event. This number will be the minimum that will be billed.

10. In the event of a total tournament/outing cancellation, notification must be provided a minimum of 14 days prior to the event for a full refund of deposit paid.
