**WAIVER AND RELEASE OF ALL CLAIMS**

Please read this form carefully and be aware in registering yourself, your child or ward for participation in the program described on the reverse side, you will be waiving and releasing all claims for injuries you or your minor child/ward might sustain arising out of this program.

As a participant in the program or the parent/guardian of a participant in the program, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, including death, damages or loss which I or my minor child/ward may sustain as a result of participating in any and all activities connected with or associated with such program.

I agree to waive and relinquish all claims I or my minor child/ward may have as a result of participating in the program against the Park District and its officers, agents, servants and employees.

I do hereby fully release and discharge the Park District and its officers, agents, servants and employees from any and all claims from injuries, including death, damage or loss which I or my minor child/ward may have or which may accrue to me or my minor child/ward as a result of participation in the program.

I further agree to indemnify and hold harmless and defend the Park District and its officers, agents, servants and employees, from any and all claims arising from injuries, including death, damage and losses sustained by me or my minor child/ward and arising out of, connected with, or in any way associated with the activities of the program.

I hereby consent to the use of my photograph or that of my minor child/ward in the Park District brochures, publication, slide presentations, etc.

I hereby consent to all the Park District to use my electronic mail address for Park District communications purposes only.

The Peoria Park District hereby leases a golf car to the lessee on the date and on the golf course indicated on this form.

Lessee agrees to return the golf car in the same condition as when received, ordinary wear and tear expected. Lessee acknowledges that the below described golf car has been received in good condition and is presently operating. Lessee agrees to pay or reimburse the Peoria Park District for any and all charges arising out of damage to said golf car.

Lessee agrees to keep the golf car in his/her custody and not to sublease it or permit any unauthorized person to operate or use it for purposes other than that for which it was designed or intended. Lessee warrants that he/she is familiar with the operation and use of the golf car and the rules covering its use, and that he/she has the ability to operate and control the golf car in accordance with such rules and will do so. The golf car is not to be removed from the golf course and it is to be returned promptly to the Park District after its use.

It is expressly understood and agreed that the Park District shall not be liable for any damages arising out of the use of the golf car. Lessee agrees to indemnify, defend and save harmless the Peoria Park District and its trustees and employees against any and all liability imposed by law and against all loss, liability, damage and expense, including attorneys' fees, incurred them or any of them on account of any injury to or death of any person or persons or on account of damaged property caused by or connected with the use of the golf car leased under this agreement.

This represents the entire agreement between the lessee and the Peoria Park District. The provisions of the agreement cannot be altered, excused or waived without the written consent of the Board of Trustees of the Pleasure Driveway and the Park District of Peoria.
