- 7-Day Adult & Junior Memberships are restricted to **85 rounds between May 1 and September 30th**. Before or after this period or after 3pm during the period memberships are valid for unlimited play.
- 5-Day Adult & Senior Memberships are restricted to **65 rounds between May 1 and September 30th**. Before or after this period or after 3pm during the period memberships are valid for unlimited play.
- 18-Hole Course Memberships will no longer be valid on the Par 3 Course when the 18-Hole Course is closed for play. 18-Hole Course members must either purchase a Par 3 Membership Add-on or pay the appropriate greens fees to play the Par 3 Course.
- All Season Memberships are valid for the 2017 golf season - 18-Hole Course Opening to 18-Hole Course closing.
