

The yearly golf car rental option does not entitle you to use a golf car exclusively. If more than one person in your group is using a rental golf car we ask that you ride together. This will ensure that cars are always available for members with the rental golf car option.

MULES NATIONAL GOLF CLUB MEMBERSHIP AGREEMENT ADDITIONAL TERMS AND CONDITIONS OF MEMBERHSIP

This agreement for golf playing memberships, when approved, is made subject to the terms and conditions set forth in the membership information publication and the following:

1.	All applications for membership shall be approved or rejected by University of Central Missouri and Mules National Golf Club.
2.	A membership, when issued, is non-transferable.
3.	A membership includes golf privileges only, with options for the driving range, golf car storage and golf car rental. Playing privileges under all memberships are subject to the rules and regulations as are adopted from time to time by Mules National Golf Club. Membership does not include share interest or ownership of any kind in Mules National Golf Club.
4.	 Membership fees shall be paid in one of the following manners: a. Membership fees paid in full upon joining. b. You may pay in twelve monthly installments. Your first and last months payments are due upon application approval, and thereafter on the 15th of each month.
5.	Membership will run one full year from the date your application is approved.
6.	University of Central Missouri and Mules National Golf Club reserves the right, at any time, to cancel the membership issued to any applicant upon 15 days written notice.
7.	Any applicant who is ten days delinquent in payment of their membership fees forfeits all rights to said membership and any fees paid.
8.	Memberships will not be refunded at any time.
