I. <u>Grant of Membership:</u>

II. Limitation to Described Purpose

The Golf Club at Surrey Hills authorizes members and their designees to play the game of golf and for incidental purpose thereon. Please refrain from using Surrey carts to fish for golf balls;

III. <u>Terms of Membership</u>

The term of this membership shall be 12 month agreement (contract) with an automatic renewal each year from the date of acceptance.

All memberships will include golf and fitness center privileges. Any member that resigns membership and applies for reinstatement will need to pay all back dues before being accepted back into membership.

Explanation of Membership Categories:

Surrey Membership

This membership is for the people falling between the ages of 40 and 64. Under the Surrey Membership, this will include Spouse and children living in the household. Children are allowed to play on Family Membership until the age of 24.

In consideration of the benefits of the promotional and other activities of the Club, I (we) hereby apply for membership at The Golf Club at Surrey Hills and agree to pay fees as set forth above. In connection with Club's review of my (our) application for charge privileges, Club is authorized to check my (our) credit and employeement history. In the event of default, member agrees to pay reasonable collection fees.
