Both of those memberships, along with their family members living at home and under the age of 24, will have complete access to all club facilities. **These memberships include, golf, carts, range balls and use of our New Fitness Center.**

The Club does have adequate space to accommodate up to 150 people for corporate meetings, gatherings or parties. Corporation will receive a discount on those rates for all such outings.
