### All Applicants

Account balances not paid by the 15<sup>th</sup> of each month will be subject to a 3% late fee based on the current amount due. Members with a history of late payments may lose their charging privileges and be converted to a cash only basis.

### Quarterly Payment Plan

Members which elect to pay quarterly must do so based on the following terms. Each member(s) agrees to make all (4) payments for 2016 as selected and outlined on page 1. Quarterly payments are due on the 1st day of January, April, July & October. Payments not received by the 15th of the month(s) will be subject to 3% late fee based on the amount currently due. A current credit card must remain on file for the 2016 membership period.

### Sale of Facility

The privileges of the Club's members will continue in accordance with the terms of this membership agreement in the event of ownership of the facility is transferred.

### Member Conduct

The membership of any person hereunder may be revoked or cancelled at any time by the management of the Club after receipt of written notice from the Club and an opportunity for an informal hearing before the Club's Management, subject to the right of such member to receive the refund value of its membership as established by the management of the Club in its sole discretion.

### Ownership

The membership of any person under this membership agreement shall not be construed to grant such member any equitable or legal ownership interest in the Club or the Club's facilities.

### Indemnification

Each member hereby agrees to release, waive, discharge and covenant not to sue and hold harmless Mountain View Golf Club, LLP, and their owners, directors, employees and agents (collectively the "releases") from any and all liabilities to such member, their successors in interest for any and all claims, demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or part by the negligence or recklessness of the releases or otherwise.

### Cancellation

Mountain View reserves the right to terminate this program any time by giving notice in writing to all members 60 days prior to termination. Upon termination of the program the Annual Fees will be refunded to the member on a pro-rata basis for the remaining months in each membership.
