Conditions of New Corporate Membership

- Upon request the Corporation must provide Transcona Golf Club with written proof as to the legitimacy of the Corporation, i.e.: A signed letter by an Authorized Representative and photocopy of the Company's Articles of Incorporation.
- **The above Corporate Representative shall have full membership privileges. With a minimum of 3 Additional Corporate Applicants**, the above Corporate Representative will also be issued certificates for 25 free rounds of golf. These can be given out by the Corporate Representatives as they see fit. The bearer of the certificate does not have to be accompanied by a Corporate Representative or Additional Corporate member.
- Additional golf passes will be available at \$25.00 per pass.
- Each corporate membership is allowed up to 10 names, and each additional membership purchased must be a member or employee of that Corporation.
