Format:

- Saturday June 9th, 18 holes of qualifying at Weibring Golf Club at Illinois State University, Normal Illinois.
- Championship Flight will consist of low 31 individual qualifiers and 2017 Champion.
- Ties for the 31st qualifying spot will be decided by a sudden death playoff beginning immediately following posting the last score or a time communicated by the golf course. It is the player's responsibility to find out what time a playoff will begin. Other ties will be determined comparing last nine, last six, last three, then hole by hole going backward.
- Tournament pairings will be posted at the Weibring Golf Club, the Pantagraph, and on the web www.isugolf.com and www.bnga.net
- Players must arrange tee times together and if a common time within the tournament time table cannot be reached, both players will be disqualified.

Registration:

- **Entry Fee: Maximum of \$100.00 per player.** Includes all tournament greens fees and \$26.00 for prize/trophy fund.
- Qualifying tee times will be assigned with paid registration only.
- Entry form must be complete and entry fees paid in full for all registered players.
- Deadline: Friday June 8, 2018 – 5PM.
- Carts are \$14.00 per player/per match. Range fee \$6.00/bucket.
