Program Details

The Country Club of Johnston County is focused on growing our Membership through the Membership Incentive Program, in which a new or returning member may experience the club and receive one month dues credit for joining. In addition, the sponsoring member will receive a one month dues credit. **The goal of this Membership Promotion is to increase our current membership base by 50 new or returning members.**

Program rules and details are as follows;

There is no initiation fee for the duration of this Membership Promotion, for any membership category.

- Each application has a place for the sponsoring members name and the prospective members name. The application must be accompanied by an application in order for the dues credit to apply.
- Membership classifications included in this program are Full Membership, Junior Membership, Social Membership and Out of County Membership.
- Regardless of the type of New Member, the Current Member refers; the Current Member will receive the dues credit established for their own Membership Category.
- Promotion Duration Period: For the first 50 new members.
- A returning member is defined as any former member of the club who resigned in good standing prior to April 1, 2016.
- A new member is defined as anyone who has never been a member of the Country Club of Johnston County.
- Current Members are encouraged to sponsor as many new or returning members as they wish. They will receive one month dues credit for each new or returning member they sponsor.
- A new or returning member is eligible to sponsor an unlimited amount of other new or returning members. They will receive one month dues credit for each new or returning member they sponsor.
- During this promotion a current Social Member may move to Full Membership and receive a months dues credit until April 1, 2018.
- The dues credit for the sponsor and new member are only applicable if both stay current in payments of dues and other charges.
- New Member must sign a 12 consecutive month commitment. The one year commitment may be cancelled prior the maturity date, but a \$500 penalty payment is due and resignation from the club is required.

Rate good for the first year. After 12 months the rate changes to the \$185.00 prevailing regular monthly rate.

(Ages 18-35)

Includes Golf, Range, Social Events, Pool and Tennis. **Trail Fee Extra!**

Social Membership: \$ 125.00 (Monthly Dues)

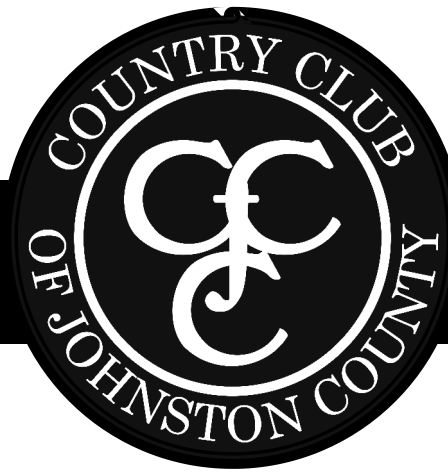
Includes Social, Pool, Tennis, and \$ 25 monthly Food Credit. **Golf and Cart Fees extra.**
