- Complimentary golf carts for rules officials and the tournament committee/volunteers
- Pre-event welcome, announcements and event instructions
- \$4pp prize fund for all events (ie.100 players X \$4=\$400 for prizes in our pro shop)

GOLF OUTING TERMS and CONDITIONS:

PAYMENT: In order to reserve the date and time indicated above, I understand and by my signature on this Contract, hereby agree to the following terms:

- This Golf Outing Contract must be signed and returned with a **\$250.00 non-refundable DEPOSIT** to formally secure the requested Outing Date. This Deposit will be applied to your final bill and can be paid with cash, check, or credit card. Please make checks payable to "Ledges Golf Club". (Under special circumstances; the deposit may be returned at the General Manager's discretion)
- **The FINAL GUARANTEE** for all golfers and diners, including all outing volunteers, will be due five (5) days prior to the Outing Date. The guaranteed number is not subject to reduction. Groups arriving with fewer than the guaranteed number of golfers and diners will be charged for the Final Guaranteed number.
- **Full payment must be paid on the day of the event.** This amount can be paid with cash, check or credit card. Please make checks payable to "Ledges Golf Club".
- **DRESS CODE:** It is the Tournament Coordinator's responsibility to notify all golfers of adherence to the dress code at Ledges Golf Club.
 - All participants must wear collared shirts and appropriate bottoms consisting of non-denim shorts or pants. Absolutely no jeans or tee shirts will be permitted. If a tournament player is not appropriately attired, he or she will not be allowed to play on the course, unless a change of attire is obtained.
 - The Ledges Golf Club is a "spike-less" facility.
- **FOOD AND BEVERAGE: All food and beverage must be purchased from or through the Valley View Restaurant.** Due to Massachusetts Liquor regulations **NO** alcohol or coolers are allowed on the golf course unless purchased from the Valley View Restaurant and/or beverage cart service. Any violation will lead to immediate removal from the golf course with no refund. Valley View reserves the right to allow coolers through a written contractual agreement only.
- **INCLEMENT WEATHER: Cancellation of the Outing will be considered only if Ledges Golf Club officially closes the course to all play.** The tournament will be rescheduled based on date availability or rain checks will be issued out.
- **FORCE MAJEURE:** Ledges Golf Club will not be liable for delays, damages or failures in performance due to events of force majeure (causes beyond our reasonable control), including, but not limited to, acts of a governmental body, acts of God, acts of third parties, fires, floods, strikes or other labor related disputes, an inability to obtain necessary equipment or services, the severing of off-site communication lines by a third party, or other events of force majeure. Either party may cancel this Agreement, with written notice to the other, without liability as a result of acts of God, over which neither party has control, government regulation, terrorism, disaster, strikes, civil disorders, unavailability of transportation facilities consistent with those in existence at the time of contract, or any other factors over which neither party has control, making it impossible or illegal to conduct the program consistent with those conditions that existed at the time the contract was executed. The parties may, however, agree to go forward on such terms and conditions that may be re-negotiated.

GOLF OUTING RULES and REGULATIONS:

- Golf cart operators must possess a valid driver’s license, maximum two riders per cart.
- All golfers must have their own set of clubs and bag. (Limited rentals are available).
- Golf cart rules can change due to daily weather conditions and time of year; cart policies for each day will be listed at the pro shop and announced to the players.
- All players must report to the starter and be ready to start playing at least 10 minutes prior to their scheduled tee time, or 30 minutes prior to a scheduled Shotgun start.
- Five-somes are not permitted unless approved by the General Manager and/or Head Golf Professional; singles and twosomes must pair up when asked by Golf Course Staff.

- **PACE OF PLAY** is vital to our operation. All groups are expected to play in 4-1/2 hours, and to keep up with the group in front of you. Rangers will be on duty, and have full authority to enforce regulations and pace of play.
- **Course etiquette.** Repair ball marks, replace divots, and rake all bunkers. Leave the course in the condition you found it, as a courtesy to the next player.

The Tournament Chairperson will be responsible for all players conduct and any damage to the golf course or golf carts. Ledges Golf Club reserves the right to inspect and control all Golf Outings. **Liability for damage to the premises will be charged accordingly.** Ledges Golf Club will not assume responsibility for injuries or for damages to personal property and equipment brought onto the premises.
