REMAINING BALANCE:

All balances will be paid the day of, before the party begins. If the party continues for an extra hour the \$25 will be paid at the beginning of that hour. Two weeks (from signing contract) written cancellation of the event is required to obtain the full return of your deposit.

FOOD AND BEVERAGE:

No outside food or beverage.

(Cakes are fine, but must be approved by Traditions)

ALCOHOLIC BEVERAGE SERVICE:

As a licensee of the State Alcoholic Beverage Control Authority, this Club adheres to all laws and regulations pertaining to services and sale of alcoholic beverages. We ask your understanding and must insist upon your cooperation is preventing sales to minors or intoxicated persons.

GUARANTEE:

An estimated attendance figure is to be provided at the time the function is scheduled. A final minimum guarantee of attendance must be provided (7) seven business days before the event, and once received may not be reduced. The minimum guarantee is used to purchase supplies and schedule staff, therefore, that number is the minimum number that you will be charged for, if fewer guests attend. If more guests attend, additional charges will be made for the number actually served over the guarantee. If a guarantee is not provided as herein stated, the estimated attendance figure automatically becomes the client's guarantee and charges will be made accordingly. All events are rain or shine on the party date. If lightning occurs during the event at any time, the pool will be closed for a period of one hour from the last lightning strike.

GRATUITY:

There will be a gratuity charge of 20% for all Food & Beverage items. Gratuity is not optional.

TAX:

Tax is included in all Party Package Prices, however, there will be a 11.5% (6.0% state of VA + 5.5% meal tax in the state of VA) tax charged on all additional Food & Beverage options not included in the package.
