I/We, the undersigned parents of _____ (“Child”) hereby consent to the Child’s enrollment in the Golf Camp program sponsored by Twin Rivers Golf Club (the “Club”).

I/We acknowledge and agree that the Camp activities will involve physical exertion outdoors by the Child as well as contact with other children attending the camp. I/We hereby warrant and represent to the Club that the Child is physically able to participate in the Camp activities. That the Child has no behavioral or psychological problems or any medical or health condition or physical limitations which would prevent the Child from participating in the camp activities. I/We hereby acknowledge and agree that the club and its representatives, agents and employees shall not be responsible for administering any medications or delivery or assistance regarding any health care to a Child.

I/We hereby authorize the Club and its representatives, agents and employees to seek medical attention and transportation of the Child if they deem any medical treatment is required, in their sole and absolute discretion.

I/We hereby grant permission for the Club and its representatives, agents and employees to transport the Child in Club authorized vehicles, including, but not limited to, passenger vans and golf carts, in connection with the Camp activities.

I/We acknowledge and agree that, while the Club will take precautions to ensure that the activities are conducted safely and supervised by qualified Club personnel, inherent in the activities is potential for accidental injury, regardless of the efforts of the Club and Club personnel. With acknowledgment of such risk, I/We agree to allow the Child to participate in the Camp activities. I/We jointly and severally do hereby forever release and agree to indemnify and hold harmless Twin Rivers Golf Club, and all their respective present, former and future partners, shareholders, officers, directors, employees, representatives, agents, associates, affiliates, predecessors, successors, and assigns, and any and all other persons, firms, entities or corporations in any way connected therewith (collectively the “Releasees”) from any and all claims, losses, demands, actions, causes of action, controversies, damages, injuries, including death, of any nature whatsoever regarding the Child’s participations in Camp, except from the willful misconduct or gross negligence of a Releasee.

I/We hereby acknowledge and agree that the Child’s enrollment and participation in Camp shall, at all times, be governed by the Club’s rules and regulations as well as the instructions from Club personnel conducting the Camp activities. The Club reserves the right, in its sole discretion, to dismiss or drop any Child from Camp, if they determine that the Child does not abide by Club rules and regulations or the instructions of Club personnel or if the Child’s continuing participation is disruptive to other participants. In the event of such a dismissal, any fee paid shall be nonrefundable.

I/We hereby agree to save, defend, indemnify and hold harmless the Releasees from and against any and all claims, losses, demands, actions, causes of action, controversies, damages, injuries, including death, of any nature whatsoever by any person or entity with respect to any of the Child’s acts or omission to act, willful misconduct or negligence.

I/We hereby grant permission for the Club to photograph or videotape the Child’s participation in Camp and authorize use by the Club of such photos and videos in connection with Camp activities and for publication and promotions of the Club.
