Pass Details:

1. SINGLE:

- a. You will have the opportunity to golf anytime during the week (Monday-Friday).
- b. Tee times are recommended to ensure availability.
- c. Advance tee times available for golf pass holders, 3 weeks in advance!
- d. Your golf pass will cover your green fees for up to 1 league.
- e. **CART FEES INCLUDED**
- f. Annual bag tag included
- g. No need to check into the pro shop, just check in with the starter and go!

2. COUPLES

- a. Couples will have the opportunity to become members together at a reduced rate. Same guidelines as stated above apply to couples depending on which Day Pass they have selected.
- b. To be eligible for a Couple membership, both members must have the same address.
 - i. **We will not accept change of address forms. Valid License only!**

3. 9 Hole Walking

- a. This rate is for players that are looking to walk 9 holes anytime during the week.
- b. Receive \$5 off rack rate if you choose to do something else besides walking 9 holes.
- c. This rate does not cover any league fee.

4. Junior Memberships (17-)

- a. Junior Members will have the opportunity to play unlimited golf* during the week (Monday-Sunday). Tee times are required during the weekend and can only be made after 2pm on weekends.
- b. Must have a valid driver's license to operate golf cart.
- c. All Cart fees are additional:
 - i. 9 Holes: \$8
 - ii. 18 Holes: \$12

Terms and Conditions

5. General

- a. Memberships are non-refundable and non-transferable
 - b. Memberships are valid for open play only. Not valid for outings or tournaments.
 - i. *The Links at Crystal Lake will **not** put members out in between Leagues.*
 - c. *Memberships are valid for a maximum of 36 holes a day.*
 - i. *If playing more than 18 holes, Members will be required to pay the full golf fee.*
 - d. Tee Times are recommended on weekdays.
 - i. Without a tee time, we cannot guarantee play.
 - ii. Tee times can only be secured if booked in advance. Bookings can be made in person or over the phone at the Pro Shop.
 - e. The Links at Crystal Lake reserves the right to shut down the course in lieu of outings taking place. Members will be notified of these dates as soon as they become available.
 - f. Adhere to local rules for the day including the specified tee of the day
 - g. Avoid slow play, always exhibit high standards of etiquette, courtesy for others and respect for the course (i.e. repair divots, rake bunkers, stay within course markings etc)
 - h. A reasonable standard of dress is expected at all times, which is at the courses discretion.
 - i. All members will be issued with an individual Golf pass card valid for the category they purchased
 - i. Member must show golf pass card when checking in at the Pro Shop. Failure to do so may result in paying the green fee for that specific tee time.
6. Member will take full responsibility for any damage done to property on the course or off the course. This includes damages caused by an errant shot (houses, cars, windows, persons, etc.) or neglect to course property (golf carts or course buildings)
7. Breach of these terms & conditions and conduct
- a. Violation of any of these terms & conditions, or conduct in a manner prejudicial to the best interests of The Links at Crystal Lake, including rude or offensive behavior, will subject the person in violation to disciplinary action, including possible termination of membership.
