Dear Tournament Chairperson,

I would like to personally thank you for your previous business or your current interest in having your group or company event at the Riverbend Golf Complex. We appreciate your loyalty to our facility, and we hope you will retain our services for any outing you may have in mind during the 2018 season.

Our complex includes a championship-caliber golf course, a covered driving range, a fully stocked discount golf shop, a dining tent seating up to 180 people and an award/scoreboard area with a complete scoring package. We are currently in the process of procuring a food and beverage service for 2018 and beyond. I will keep you updated with any information as the process progresses. Please let me know if you have any questions.

Riverbend Golf Complex will do the best we can to accommodate any of your tournament needs, including modified shotguns, please enquire with any questions.

Enclosed you will find a tournament packet explaining provisions and responsibilities at our course. If you decide to choose our facility as your venue, please review the contract information carefully and send it back promptly as our schedule for the 2018 season will fill up quickly.

In completing your tournament contract, please list the following: two possible dates your event could be scheduled, the estimated number of players, and the approximate starting time. Please return your contract, along with a deposit of \$250. Shotgun event contracts must be accompanied by a \$750 deposit. All payments must be via check or credit card. All requests will be compared and tournament dates will be finalized by March 31, 2018. We will give our return customers top priority, so please take advantage of this early proposition.

Please give special notice to our firm guidelines: a solid count of players, any food requests, any damage caused to our facility during your event and final payment must be received no less than seven days prior to your event's date. If payment is not received seven days in advance, your event will be canceled. We do not give refunds for player no-shows, bad weather, or cancellations.

**It is the tournament chairperson's responsibility to ensure that each tournament attendee receives a copy of the following rules.**

1. Tournaments will start from the #1 tee and tee time intervals will alternate every nine minutes. A course starter will be on the 1st tee to assist your players, and all tournaments must stay on time notwithstanding prior delays.
2. Every tournament contestant should arrive at the complex at least 30 minutes prior to their tee time.
3. All players must have their own set of golf clubs. Srixon golf club rentals can be reserved at \$30 for 18 holes and \$20 for 9 holes. A 7-day advance payment is required for all reserved rental sets.
4. It is unlawful to bring your own alcohol to the complex. No ice chests or coolers are allowed. In accordance with the state liquor law, our complex is a licensed premise. This rule is strictly enforced and violators will be asked to leave.
5. It is expected of all tournament players to maintain the golf course by fixing ball marks, replacing divots, raking sand bunkers, and observing all posted golf course and power car rules.
6. During the course of tournament play, course marshals will make sure your group's pace of play does not exceed 4.5 hours for your 18 hole round. Please honor all marshal requests - those playing behind you will appreciate it.
7. All tournament participants must have some golfing knowledge. We ask that your players have the ability to advance the golf ball and have the understanding that each foursome must maintain its position on the golf course at all times. Violators will be asked to pick up the pace twice. After two requests, slow players may be asked to leave the course.
9. All tournament players must play from the white or yellow tees. Championship tee usage will not be allowed.
10. Any destruction caused to the golf course and/or club and power car rentals while in the tournament groups' possession, normal wear being accepted, shall be billed directly to the tournament chairperson.
11. We are currently in the process of procuring a food and beverage service for 2018 and beyond. I will keep you updated with any information as the process progresses. Please let me know if you have any questions.

***The staff and I have the ability to revoke playing privileges of any player we deem uncooperative or unruly. We want all of our golfing patrons, tournament players included, to have an enjoyable experience at the Riverbend Golf Complex.***
