2019 “Turning 70” Membership Promotion Win 3 years Free Dues

In 2019 the WYCC will celebrate its 70th Birthday. In anticipation of that celebration we are holding the largest promotion in Club History . Everyone, existing members and new members, will be able to benefit from and participate in this Promotion. Here’s how it works:

The Raffle

- A. There will be a raffle to award one member, existing or new, 3 years of free dues. There are 3 ways to get raffle tickets.
 - a. When you recruit and sponsor a new member you receive 2 Raffle Tickets.
 - b. When you become a new member and sign a 1 year contract with the Club you receive 1 Raffle Ticket.
 - c. Members may purchase an unlimited number of Raffle Ticket(s) for \$250 each.
 - d. The raffle will be held at a club party free to all raffle ticket holders. A year-long celebration of our 70th birthday will begin with this party.

Credits for Existing Members

Every member who recruits a new member will receive valuable credits. These credits will be received monthly until Dec. 31st, 2019. Credits will vary based on membership class of the new member.

- A. Recruit a new Regular member and earn a \$25 monthly credit.
- B. Recruit a new Marina Only, Dine & Wine, Young Professional or a Non-Resident member and earn a \$15 monthly credit.
- C. Recruit a new golfing member and earn a \$20 monthly credit.

Example: Recruit a new Regular Member effective Feb. 1, 2018. Receive 23 months of \$25 monthly credits. Total value \$575.

Promotion Details

The Raffle

1. The promotion will begin December 3, 2018 and ends December 31, 2019. The board reserves the right to extend this date.
2. The winner will still be obligated to pay dining minimums, capital funds, and all other charges on the members monthly bill. Only dues are awarded in the raffle.
3. In the event the newly recruited member resigns from the club, or becomes in arrears on monthly payments to the club, the free dues credits will cease for the sponsoring member.

Credits for Existing Members

1. Credits will begin the first full month of the recruited new members' membership.
2. Credits will apply to club charges only. They cannot be applied to dining minimums or capital fund fees. Examples: Credits can be applied to pro shop charges, fuel charges or food and beverage charges.
3. Credits will cease in the event the new member resigns from the Club or becomes in arrears on monthly payments to the Club.
4. New Members become eligible to receive raffle tickets and Club credits once they have joined the Club by recruiting new members.

Promotional Pricing for New Members

1. All new membership categories include use of the pool when it is open.
2. All new membership categories include discounts for fuel sold in the marina.
3. All new members will sign a one year contract. Early cancellation incurs a \$750 charge.
4. Each new membership category also is subject to initiation fees (unless waived for this promotion), \$100 refundable stock purchase, dining minimums, and capital fund fees listed below:
5. New Marina members will have to pay guest green fees to use the golf course. Members who wish to use golf course on a regular basis should consider a Regular Membership.
6. Marina members will be charged a flat fee for unmetered electric usage or actual electric usage based on the metered rate.
7. Slip selection is made at the discretion of the Dock Master.
8. New Regular Members will incur an additional charge of \$1.99/ foot for an uncovered slip or \$2.43/foot for a covered slip for their boat.
9. Golfing Memberships do not include a slip in the marina. Members who wish to use the marina should consider a Regular Membership.
10. A Single Golf Membership allows one designated family member to use the golf course. All other family members will be considered guests on the golf course.
11. A Family Golf Membership allows all family members to use the golf course as members.
12. All new membership applications are subject to approval by the board.
13. New members are subject to all Club rules.
14. Promotional pricing will convert to standard Club pricing on December 31, 2019.

Members of the board of directors are not eligible to enter the raffle. They may receive dues credits for new membership recruitment.
